Action Taken Report

Feedback is the backbone of any institution. No institution can grow and make arrangements for the betterment of the institution without taking feedback from different stakeholders. In order to ensure constant growth of the institution and progress of the students, we have collected feedback in blended mode from different stakeholders and analysed it. A structured questionnaire consisted of multiple-choice questions and one descriptive question was prepared and shared with different stakeholders to develop the road map for the academic year ahead.

A total of 1109 curriculum based (subject wise) questionnaires were filled by students. Almost 80-85 percent agreed with the objectives and suitability of the course content, balance between theory and application and its completion within stipulated time period. They were also satisfied that the course created interest in the subject area and helped in developing their personalities. Almost 70-77 percent agreed with the practical relevance of the curriculum in resolving daily life problems and availability of sufficient number of prescribed books and reference material in the library. The analysis of the feedback educed that there is a need to enrich the library, to revise the curriculum and to introduce skill-based courses to resolve daily life problems.

A feedback from the teaching faculty of the college was taken to have suggestions regarding curriculum enhancement. 96 percent agreed with the suitability of curriculum and evaluation methods mentioned in the syllabus whereas 80-88 percent agreed that curriculum is intellectually stimulating, there are prospects for higher education and it is completed within stipulated teaching days. They admit that they have the freedom to adopt new techniques of teaching. Almost 71-80 percent agreed that a sufficient number of prescribed books and reference material is also available in the library; there is a conducive teaching environment in the college; syllabi have well defined aims and objectives that help to bridge the gap between theory and application.

A feedback from 55 alumni of the college was taken to have suggestions regarding curriculum enhancement. Almost 80-90 percent agreed that the curriculum enhanced their practical knowledge, developed their critical and analytical thinking and encouraged them to contribute for the welfare of the community. 70-75 percent agreed that the curriculum generated in them the ability to work effectively with people of diverse cultures and contributed to their overall development.

To know whether there was a need to revise the curriculum, feedback forms were filled by 22 parents. 67 percent agreed that the curriculum is intellectually stimulating and completed within stipulated time. Almost 70-77 percent agreed with the suitability of the course content; its aims; practical relevance; inculcation of moral values among their wards and they were also satisfied with the books available in the library. 81-86 percent agreed that curriculum developed personalities of their wards and there were prospects for higher education/employability.

Feedback analysis report was prepared on the basis of responses received from all the stakeholders regarding curriculum designing, its implementation and its applicability. It was found that all the responses were positive in this regard. Then,a feedback analysis report was discussed in the IQAC meeting as well as with various stakeholders and an action taken report was prepared. After the approval of governing body, this action taken report was forwarded to concerned Departments of the affiliating university, KUK The following suggestions were received from the stakeholders::

- 1. Specific revision of curriculum was suggested.
- 2. It was suggested that Seminars/ Presentations and Project work/Internship should be part of the curriculum.

The above mentioned suggestions were forwarded to the affiliating university by each department. On the basis of suggestions other than above mentioned, the following actions were taken by the college administration.

Suggestion: Discipline Should be maintained properly to create a healthier academic environment atmosphere should be created.

Action taken: Discipline Committee was directed to prepare the roster for the proctorial duty of all the staff members to ensure the discipline in the corridors and campus.

Suggestions: Need of practical aspects of curriculum for up gradation of students skill; field Study may be added for 6th sem; Course Outcomes should be designed by the concerned university; Aims and objectives of the syllabi should be clearly defined and modifications in the syllabi should be done accordingly; Internship/ practical training should be a part of syllabi to acquire skills so that syllabi bridges the gap between theory and practical applications.

Action taken:1. Forwarded to affiliating university for appropriate action.

2. To enhance the students skills, four skill based certificate courses approved by UGC under Jeevan Kaushal scheme and two other certificate courses were proposed for the academic year 2020-21.

Suggestion: One full Syllabus test should be conducted before the exams and Class tests should be taken in a scheduled manner.

Action taken: Departments were directed to conduct this type of exam at their own level.

Suggestion: Curriculum should generate the ability to work effectively with people of diverse cultures

Action taken: Community outreach programmes and frequent visits to nearby villages for this purpose were proposed to be undertaken.

Suggestion: More books are required in the library.

Action taken: The librarian was directed to enrich the library as per the requirements of the stakeholders.

In order to know the view of students about curriculum of Chemistry, feedback is taken from students of B.Sc (I, II and III year students).

The feedback has been taken by taking the responses of the students in a Feedback form (Hard Copy). The questionnaire consists of 18 questions, 17 questions are multiple choice questions and 18th question is for specific suggestions. All questions are compulsory for the respondents. All questions are directly related to the present scheme and syllabi (Theory and Practical both) of Chemistry and its relevance to employability and higher studies.

A detailed analysis is as follows:

- 1. 90% students agreed and strongly agreed that the syllabus of Chemistry is suitable for the present course. Its aim and objectives are well defined and clear.
- 2. 70% students are agreed and strongly agreed that Syllabus has a good balance between theory and applications; and Syllabus generates interest in the subject area.
- 3. 83% students are agreed and strongly agreed that Syllabus is intellectually stimulating and helps students to develop their personalities.
- 4. 92% students are agreed and strongly agreed that Syllabus has prospects for higher education/employability.
- 5. 85% students are agreed and strongly agreed that Syllabus has moderate length to be completed within stipulated teaching days by the teacher and it has practical relevance to resolve daily life problems.
- 6. 86% students are agreed and strongly agreed that Industrial Training/ Industrial visits/ Project work/ Visit to various Pharmaceutical/Research/Industrial Laboratories should be a part of Curriculum/Syllabus.

7. 90% students are agreed and strongly agreed that Visit/Lectures of Analytical Chemists should be conducted during practical classes. Contents based on testing of adulteration in Food/Drinking water and practical knowledge of handling of daily used chemicals should be incorporated in Curriculum/Syllabus.

You are therefore requested to consider the above analysis and do the needful.

Report of the Online Curriculum Feedback Survey

An online feedback for design and review of curriculum of English was taken from a random selection of 45 students of B.A. 1st year to assess their responses on the curriculum transaction, efficacy and assessment. The analysis and interpretation of the feedback received from the students resulted in the following outcome: Most of the students (71% to 88.9%) agree that the texts prescribed in the syllabus are relevant to enhance their understanding of life; that the story and essays prescribed in the syllabus help the students to understand the real life situation in life Grammar and vocabulary to develop their proficiency in language; that the Phonetic transcription of speech sounds prescribed in the syllabus improves their speaking skills; that Curriculum is suitable to the Course/Subject; that aims and objectives of curriculum are well defined and clear; that curriculum generates interest in the subject area; that curriculum is intellectually stimulating and helps students develop their personalities; that curriculum has prospects for higher education/employability; that syllabus has moderate length to be completed within stipulated teaching days by the teacher and sufficient number of prescribed books and reference material on the syllabus is available in libraries. Few students (2.2% to 13.3%) do not agree with the statements whereas some students (6.7% to 24.5%) are not sure.

An online feedback for design and review of curriculum of English was taken from a random selection of 38 students of B.A. 2nd year to assess their responses on the curriculum transaction, efficacy and assessment. The analysis and interpretation of the feedback received from the students resulted in the following outcome: Most of the students (81.6% to 94.8%) agree that the texts prescribed in the syllabus are relevant to enhance their language skills; that the vocabulary exercises and topics of grammar prescribed in the syllabus develop their proficiency in language; that the interconnectedness of prescribed syllabus makes it comprehendible; that Curriculum is suitable to the Course/Subject; 89.5% agree that aims and objectives of curriculum are well defined and clear; that curriculum generates interest in the subject area; 86.9% agree that curriculum helps students develop their personalities; that curriculum has prospects for higher education/ employability; that syllabus has moderate length to be completed within stipulated teaching days by the teacher and 86.8% agree that sufficient number of prescribed books and reference material on the syllabus is available in libraries and 76.3% agree that curriculum is intellectually stimulating. Few students (1% to 8%) do not agree with the statements whereas some students (2% to 19%) are not sure(copy attached).

An online feedback for design and review of curriculum of English was taken from a random selection of 83 students of B.A. 3rd year to assess their responses on the curriculum

transaction, efficacy and assessment. The analysis and interpretation of the feedback received from the students resulted in the following outcome: Most of the students (84% to 96%) agree that the texts prescribed in the syllabus are relevant to enhance their understanding of life; that the vocabulary exercises and topics of grammar prescribed in the syllabus develop their proficiency in language; that the Phonetic transcription of speech sounds prescribed in the syllabus improves their speaking skills; that Curriculum is suitable to the Course/Subject; that aims and objectives of curriculum are well defined and clear; that curriculum generates interest in the subject area; that curriculum is intellectually stimulating and helps students develop their personalities; that curriculum has prospects for higher education/ employability; that syllabus has moderate length to be completed within stipulated teaching days by the teacher and sufficient number of prescribed books and reference material on the syllabus is available in libraries. Few students (1% to 06%) do not agree with the statements whereas some students (2% to 13%) are not sure.

An online feedback for design and review of curriculum of English was taken from a random selection of 10 students of B.Sc. 1st year to assess their responses on the curriculum transaction, efficacy and assessment. The analysis and interpretation of the feedback received from the students resulted in the following outcome: Most of the students (40% to 80%) agree that the texts prescribed in the syllabus are relevant to enhance their understanding of life; that the poems and essays prescribed in the syllabus are thought provoking and help the students to understand the real life situation in life, Grammar and composition to develop their proficiency in language; that Curriculum is suitable to the Course/Subject; that aims and objectives of curriculum are well defined and clear; that curriculum generates interest in the subject area; that curriculum is intellectually stimulating and helps students develop their personalities; that curriculum has prospects for higher education/employability; that syllabus has moderate length to be completed within stipulated teaching days by the teacher and sufficient number of prescribed books and reference material on the syllabus is available in libraries. No student (do agree with the statements whereas many students (20% to 60%) are not sure.
