Dear Sir,

You might have received the telegram dated 11.7.75 issued by this office and its copy by post vide this office Endst.No. CUR/II-72/75/5783 dated 11.7.75 on the subject cited above. As intimated therein, the Vice-Chancellor, exercising his powers conferred upon him under Statute 4(iv) of this University, has accepted the report of the Inspection Committee and consequently granted provisional recognition to your proposed (new) college in Pre-University (Arts), Pre-University (Commerce), (one unit of 60 students now raised to 80 students), B.A. Part-I and B.Com. Part-I (one unit of 60 students now raised to 80 students) for one year, in the first instance, w.e.f. the academic session 1975-76, subject to the fulfilment of the following conditions:-

- i) Four lecture rooms and two small rooms for tutorial classes be provided within 6 months from the start of the academic session 1975-76.
- ii) One lecturer each for every Arts subject and two lecturers for Commerce be appointed, immediately, but before 31.8.75, at the latest.
- iii) Regular tutorials in each subject for B.Com. Part-I, with each group of 10 students be ensured.
- iv) Books and Journals in Arts and Commerce subjects worth Rs. 15,000/- and Rs. 10,000/-, respectively, be purchased by the end of September, 1975.
- v) Ten typewriters for Pre-University (Commerce) and two calculating machines for B.Com. Part-I class be purchased by the end of September, 1975. If the number of students enrolled exceeds 40, one typewriter after every 4 additional students be added.
- vi) One qualified D.P.E. and one qualified Librarian be appointed, immediately, but before 31.8.75, at the latest.
- vii) Spacious grounds be provided within 6 months from the start of the academic session 1975-76.

I am also directed to request you to kindly fulfil the above-mentioned conditions within the stipulated period, under intimation to this office.
