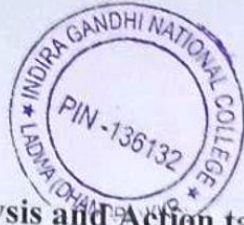


## Curriculum Feedback Analysis and Action taken report (2020-21)


Respected Sir,


1. Syllabus of Corporate Accounting BC-301 and Business Law paper BC-401 should be reduced.



R/Sir,




1. They suggested that there should not be any overlapping of the games in the university annual sports calendar. It reduces their chances to participate in university Inter-College tournaments.







Dear Sir/Madam

In order to know the view of students about curriculum of Chemistry, feedback is taken from students of B.Sc (I, II and III year students).

The feedback had been taken by taking the responses of the students through Online mode i.e. in a Feedback form (Google Form). The questionnaire consists of 20 questions, 19 questions are multiple choice questions and 20<sup>th</sup> question is for specific suggestions. All questions were compulsory for the respondents. All questions are directly related to the present scheme and syllabi (Theory and Practical both) of Chemistry and its relevance to employability and higher studies.


A detailed analysis is as follows:


1. 96% students agreed and strongly agreed that the syllabus of Chemistry is suitable for the present course. Its aim and objectives are well defined and clear.
2. 84% students are agreed and strongly agreed that Syllabus has a good balance between theory and applications; and Syllabus generates interest in the subject area.
3. 81% students are agreed and strongly agreed that Syllabus is intellectually stimulating and helps students to develop their personalities.
4. 83% students are agreed and strongly agreed that Syllabus has prospects for higher education/ employability.
5. 76% students are agreed and strongly agreed that Syllabus has moderate length to be completed within stipulated teaching days by the teacher and it has practical relevance to resolve daily life problems.

6. 81% students are agreed and strongly agreed that Industrial Training/ Industrial visits/ Project work/Visit to various Pharmaceutical/Research/Industrial Laboratories should be a part of Curriculum/Syllabus.
7. 81% students are agreed and strongly agreed that Visit/Lectures of Analytical Chemists should be conducted during practical classes. Contents based on testing of adulteration in Food/Drinking water and practical knowledge of handling of daily used chemicals should be incorporated in Curriculum/Syllabus.
8. 69% students are agreed and strongly agreed that online teaching is suitable for delivery of contents.
9. 70% students are agreed and strongly agreed that Classroom teaching is better than online teaching.

You are therefore requested to consider the above analysis and do the needful.

### Report of the Online Curriculum Feedback Survey

**Students feedback and analysis report of the Political science Department for the session 2020- 2021.**

For the amendment and refinement in the current syllabus we required time to time students feedback and their suggestions on the basis of these aspects the department is submitting a collective report to the college IQAC committee.

Total 27 students in B. A.1 year class have reported their responses. The questionnaire consisted of 12 multiple choice questions of some personal details . All questions were compulsory for the respondents. All questions are directly related to the present structure of Political Science.

More than 88% of students agreed and strongly agreed that the syllabus of Political Science is suitable for the present course. Its aim and objectives are clear and well defined and it is helpful in prospects for higher education and employability. They also agreed that the length of the course is moderate and is completed by the teacher within stipulated teaching days because it is designed meticulously and divided in units. It's directly helpful to understand the working of the Government at centre, state and local level. They agreed that the syllabus helps to understand the present scenario of the government and develop the personality of them.

More than 75% students agreed and strongly agreed that the syllabus intellectually stimulates the students to generate interest in the subject area and the sufficient number of prescribed books and reference materials on the syllabus is available in the college library.

Total 30 students of BA 2nd year class have reported their responses to the questionnaire consisted of 12 multiple choice questions that were directly related to the present structure of Political Science.

More than 84% students agreed and strongly agreed that the syllabus of political science Indian political thinkers is suitable for the present. Its aim and objectives are clear and well-defined and the syllabus is helpful in the prospect of higher education, employability

and their personality. The students agreed that it helps them to acquire knowledge regarding the lifestyle and status of Political thinkers. The syllabus is helpful in prospectus for higher education and employability; they also agreed that the length of the course is moderate and is completed by the teachers within stipulated teaching days.


It has practical relevance to resolve daily life problems and the syllabus intellectually stimulates the students to generate interest in the subject area and it gives the fullest knowledge about the views of Political Thinkers.. They agreed that the sufficient number of the prescribed books and the reference material on the syllabus is available in the college library.

Total 43 students of B.A. 3rd year class reported their question responses, the question paper consisted of 12 multiple choice questions related to Political Science.

More than 80% of students agreed and strongly agreed that the syllabus of political science is suitable for the present course. It's main and objectives are clear and well defined, it has a good balance between theory and practical application and it also generates interest in the subject area increases knowledge about comparative study they agreed the syllabus intellectually stimulating the students to generate interest in the subject area and it has prospect for higher education and employability.

More than 72% students agreed that the syllabus length of the course is moderate and completed by the teachers within stipulated teaching days and the sufficient number of the prescribed books and reference material on the syllabus is available in the college library.

One general question was asked to the students for any suggestion to enhance the curriculum. The following suggestions were received from the teachers and students:

1. Seminars and presentation should be included in curriculum.
2. Syllabus of Quantum and atomic spectroscopy should be reduced.
3. Guest Lectures on various topics of Quantum Mechanics paper should be include.
4. Syllabus of Statistical Physics should be reduced.
5. Syllabus of Optics-II paper should be reduced.
6. Syllabus of Electronics should be reduced.
7. Project work should be included in curriculum.
8. Mode of teaching should be in blended mode.
9. Visit to various Research Institute/ Universities should be a part of Curriculum/Syllabus.
